"Stacie and I are grateful to be called to serve at Saddleback Church," Andy Wood told Baptist Press. "We are not co-pastors but rather have unique roles on staff. I'm serving as the lead pastor and one of our Saddleback overseers while Stacie is serving as one of our teaching pastors.

"We believe pastoring and teaching are functions and spiritual gifts to be exercised in the church by both men and women. The function of teaching and pastoring is not necessarily synonymous nor exclusive from the office of overseer," he said.

"While many SBC churches share the same view, we are committed to stay in fellowship and unified with other SBC churches even when we disagree. Saddleback Church has a strong commitment to the authority and inerrancy of the Bible," Wood said. "We believe this approach is biblical and in alignment with the teachings of the New Testament as well."
